Applications are invited from bonafide residents of Chhattisgarh in prescribed form for admission to the **M. Pharm. (Pharmaceutics)** of the Institute, for the academic session commencing 2011-2012. Admission to M. Pharm programme will be on the basis of GPAT score.

Eligibility for Admission

The candidate for admission in M. Pharm First Semester should be a bonafide resident of Chhattisgarh, passed B. Pharmacy from AICTE/PCI approved institute with 60% marks (55% for SC/ST candidates) and GPAT score. Candidates not having positive GPAT score card are not eligible for application.
